DISCUSSION AND ACTIONS TAKEN:

SIDEWALK ISSUES -

We discussed the low tree limbs when walking on side walks, and that those neighbors need to be aware of the need to trim the low hanging tree limbs. Also for those neighbors who have a driveway which crosses a sidewalk, need to know that we cannot block a side walk and we can cited by the city for doing so.

We discussed only parking on one side of the streets, so we're not blocking emergency and other vehicles from coming through. Discussion led to request of the Political Committee to research the possibilities of having the Metro Government install "No Parking" signs on one side of Neighborhood streets.

Speeding vehicles in the neighborhood was again discussed with the Speed Bump as a solution. Brooke noted that our last request was turned down two years ago but that the time limit to reapply is about to expire. She volunteered to request a 'no cost' study by Metro Gov't; determine the cost of Speed Bumps and report back to the Board.

Dog Poop Pickup and the lack of it was discussed. Anne-Britton offered a solution of bag dispensers. Her family has volunteered to construct and she will report back to the Board on cost and appropriate design. Board will decide on approval and placement at a later date.

STREET ISLAND MAINTENANCE -

We discussed the island for mulch, and weeding, and some trees that are hanging out on the street and blocks our views of on coming cars. Greg's yard maintenance guy will take care of mulch, and trees as soon after Aug. 17th. Trimming the Evergreen tree and Brownsboro and University, tree(s) at Riedling and Birchwood, mulching the islands will be at a cost of \$1000. Board approved.

We will ask Noel as Chair of the Green Committee to see if Mary can do any weeding prior to the 17th..

NEIGHBORHOOD ENTRANCE SIGN MAINTENANCE -

Mike Presnell needs the color and tree graphic design for the new inserts on the street entrance signs.
